AGUAS BUENAS, PUERTO RICO, TO THE TERRORIST ATTACKS PERPETRATED ON SEPTEMBER 11, 2001 IN THE CITIES OF NEW YORK, WASHINGTON D.C. AND PITTSBURGH, PENNSYLVANIA IN THE UNITED

STATES OF AMERICA.

WHEREAS:

On September 11, 2001the United States of America awoke to what has been described as the most vicious and cowardly terrorist attack ever perpetrated in the After hijacking two commercial passenger airplanes in route to Los Angeles, the terrorists altered their flight plans and directed them towards the Twin Towers of the World Trade Center in New York City, crashing against both buildings. This led to their collapse and caused the death of countless persons who worked there and rescue brigades who had arrived at the victims of this horrific national tragedy. While these acts of terrorism planted the seeds of destruction in the heart of the financial district of New York City, at the Nation's Capital, a third aircraft crashed against the Pentagon, seat of Department of Defense. In the state of Pennsylvania, in the vicinity of Pittsburgh, a fourth airplane crashed. These acts have caused worldwide consternation.

WHEREAS:

The Municipal Government of Aguas Buenas, Puerto Rico and the People of Aguas Buenas, join the United States of America in its profound pain for such a despicable and devastating attack which attempts to undermine the foundations of the democratic values of freedom, dignity and justice that this Nation proclaims and treasures. We express our support and condolences to the President of the United States of America, the Members of the Congress, the Governor of the State of New York City, the Mayor of New York City, the Mayor of Washington D.C., and the Governor of the State of Pennsylvania, and all our fellow citizens, and join them in prayer for this despicable and unimaginable attack to be clarified and for peace and safety to once again reign after all these tragic events.

THEREFORE:

BE IT RESOLVED BY THE MUNICIPAL ASSEMBLY OF AGUAS BUENAS, PUERTO RICO:

SECTION 1:

To express our solidarity and support to the People of the United States of America and the condemnation and indignation of the Municipal Government and People of Aguas Buenas, Puerto Rico to the vicious and barbaric terrorist attacks perpetrated on the morning of September 11, 2001 in the cities of New York, Washington D.C. and Pittsburgh, Pennsylvania in the United States of America.

SECTION 2:

A copy of this Resolution shall be remitted to the Honorable George W. Bush, President of the United States of America; to the Honorable George Pataki, Governor of the State of New York; to the Honorable Rudolph Giuliani, Mayor of New York City; to the Honorable Antony A. Williams, Mayor of Washington D. C.; to the Honorable Tom Ridge, Governor of Pennsylvania and to all Members of Congress.

SECTION 3:

This Resolution shall take effect immediately after its approval.
