

RESOLUTION AUTHORIZING THE FILING OF (AN) APPLICATION(S) WITH THE DEPARTMENT OF TRANSPORTATION, UNITED STATES OF AMERICA, FOR(A) GRANT(S) UNDER THE URBAN MASS TRANSPORTATION ACT OF 1964, AS AMENDED.

WHEREAS: The Secretary of Transportation is authorized to make grants for mass transportation projects;

WHEREAS: The contract for financial assistance will impose certain obligations upon the applicant, including the provision by it of the local share of project cost;

WHEREAS: It is required by the U.S. Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Urban Mass Transportation Act of 1964, as amended, the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

WHEREAS: It is the goal of the Applicant that minority business enterpriss be utilized to the fullest extent possible in connection with this/these project(s), and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts, or consultant and other services:


WHEREAS: NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL ASSEMBLY OF AGUAS BUENAS, PUERTO RICO:


1. That the Mayor Carlos Aponte Silva is authorized to execute and file (an) application(s) on behalf of the Municipality of Aguas Buenas with the U.S. Department of Transportation to aid in the financing of planning, capital and/operating assistance projects pursuant to Section 9 of the Urban Mass Transportation Act of 1964, as amended.
2. That the Mayor is authorized to execute and file with such application an assurance of any other document required by the U.S. Department of Transportation may require in connection with the application for the program of projects.

3. That the Mayor is authorized to furnish such additional information as the U.S. Department of Transportation, and to execute and file with such applications an assurance of any other document required effectuating the purposes of Title VI of the Civil Rights Act of 1964.
4. That the Mayor is authorized to set forth and execute affirmative minority business policies in connection with the program of projects' procurement needs.
5. That the Mayor is authorized to execute grant agreements on behalf of the MUNICIPALITY OF AGUAS BUENAS with the U.S. Department of Transportation to aid in the financing of planning, capital and/or operating assistance program of projects.
6. Because this resolution is very urgent and necessary it will go into effect as soon as it is approved by the Municipal Assembly and signed by the Mayor.
7. Copy of this Resolution will be sent to all concerned Agencies for their knowledge and corresponding action.


